



## **Randolph Sponsored One-Day BRC “Conversion” Workshop for Food Plants**

Randolph Associates, Inc. is collaborating with Mr. John Kukoly, North American Director for the British Retail Consortium (BRC) to sponsor a one-day workshop that will identify the specific differences between the existing 5<sup>th</sup> Issue of the BRC Code and the new 6<sup>th</sup> Issue (effective January 1, 2012). All BRC-certified plants that have to be recertified after January 1, 2012 will need to modify their written BRC manual and supporting operational and records systems to comply with the new 6<sup>th</sup> Issue or jeopardize their BRC certification status. Key changes for Issue #6 include, but are not limited to:

- Expanded sections on foreign body control, hygiene and housekeeping, and allergens.
- Introduction of a new voluntary 2 stage unannounced audit scheme.
- A reduced number of clauses and clearer language to improve consistency of grading and audit scoring.
- Identification of specific prerequisite programs.
