

**Randolph Sponsored
BRC Auditor Certification Workshop
February 7 – 10, 2012

Randolph is collaborating with John Kukoly, North American Director for the British Retail Consortium (BRC) to sponsor an intense workshop that will prepare attendees for the final step in becoming a **BRC-certified third party auditor**.

Prerequisites for participating in the BRC Auditor Certification Workshop are:

- Certificate of at least 16 contact hours of recognized HACCP training
- Food Industry audit experience equivalent to a “Lead auditor” or a “Lead auditor” certification
- Operational and working knowledge of the 6th Edition of the BRC Code (provided to all registrants 2 weeks prior to the Workshop)
- Completion of BRC Code homework prior to the start of the Workshop

All individuals that successfully complete the Randolph-sponsored BRC Auditor Certification Workshop will be ready to complete the last remaining step to become a BRC recognized auditor, i.e. completing a series of witness / shadow audits with a qualified auditor. While this is not part of the Workshop offering, Randolph will attempt to coordinate the witness/shadow audit requirements with successful workshop candidates so the lag time between the workshop and full BRC auditor certification can be minimized.

PROGRAM SCHEDULE:

The workshop is being held in Birmingham, Alabama starting at **1:00 pm CST, Tuesday, February 7th and ending at 5:00 pm on Friday, February 10th**. There will be evening sessions on both Tuesday and Wednesday running from 6:00 pm until 8:00 pm. Because of the importance of all attendees meeting very high competency levels, the total workshop size is limited to 12 individuals.

REGISTRATION:

Interested candidates need to submit a resume that includes past HACCP training and audit experience including any audit experience in any of the other GFSI-recognized schemes such as SQF, IFS or FSSC22000. Randolph will determine whether interested candidates qualify and will notify them whether they have been granted a registration for the Workshop.

The fee for the 4-day intense BRC Auditor Certification Workshop is \$1,250. This fee needs to be submitted along with the registration and audit experience information. For those candidates that are not offered a registration, their fee will be refunded.
